T1.1 : TENDER NOTICE AND INVITATION TO TENDER

Bergrivier Municipality invites tenders for Tender 8/3/30-2018 for the construction of a new 11kV switching station with 5 x circuit breakers and associated work in Velddrif.

Only bidders who satisfy the eligibility criteria stated in the Standard Conditions of Bid (Clause F.2.1) are eligible to submit tenders.

It is estimated that tenderers should have a minimum **CIDB contractor grading designation of 4EP or higher**.

Only goods, works and services with a stipulated minimum threshold as applicable for local production and content will be considered.

All bids received shall be evaluated in terms of the Bergrivier Municipality's Supply Chain Management Policy, read with the Preferential Procurement Regulations of 2017. It is estimated that the 80/20 preference points system will be applicable. Tenders will be evaluated in terms of price and preference.

The successful Tenderer must be registered on the Centralized Supplier Database (CSD). Tenderers can register on www.csd.gov.za.
