SUPPLY AND DELIVERY OF uPVC PIPES, FITTING, BULK WATER METERS AND RELATED FITTINGS: GOEDVERWACHT

Bids are invited from registered and authorised service providers for the supply and delivery of uPVC pipes, fitting, bulk water meters and related fittings at Goedverwacht as described in the specifications and drawings.

Bids in a sealed envelope, clearly marked "**TENDER: 8/3/7-2018: SUPPLY AND DELIVERY OF uPVC PIPES, FITTING, BULK WATER METERS AND RELATED FITTINGS, GOEDVERWACHT**" must be placed in the tender box at the Municipal Offices, 13 Church Street, Piketberg by no later than **12:00 on Friday, 6 April 2018** when the bids will be opened in public.

Bid documents may be collected from Ms M van Zyl or Ms L Parks at 13 Kerk Street, Piketberg 7320 during working hour 07:30-15:00 from Monday 26 March 2018 at a non-refundable fee of **R300.00 per set**. Only cash payments or cheques made out in favour of Bergrivier Municipality will be accepted. Bids will be evaluated using the Council's Supply Chain Management Policy. It is therefore compulsory that the Preference Point Claim form for the Preferential Procurement regulations is completed in full to make application for preference points. Bids may only be submitted on the standard tender documents that are issued. There will be no benefits if the schedule is not thoroughly completed. Bids shall be valid for a period of **90 days** from the closing date.

The bid price must be VAT inclusive.

Bidders must be registered as a prospective supplier on National Treasury's Central Supplier Database (CSD). The Tax Clearance Certificate/Tax Compliance Status (TCS) Pin/CSD registration number must be submitted together with the bid. Failure to submit a Tax Clearance Certificate/TCS/CSD registration number may result in the invalidation of the bid.

Only bids completed in **black** ink on the original bid documentation will be accepted. Late, incomplete or bids submitted by facsimile or email will not be accepted. Proof of submitting a bid will not be accepted as proof of the bid having been received. The Municipality is not obliged to accept the lowest or any bid submitted to it. The Municipality reserves the right to accept any bid in full or in part.
