## **TENDER 8/3/5-2020 MN9/2020: APPOINTMENT OF CONSULTING ENGINEERS FOR VARIOUS PROJECTS IN BERGRIVIER MUNICIPAL AREA FOR A THREE (3) YEAR PERIOD**

Tenders are invited from suitably experienced firms with appropriately qualified personnel to provide **PROFESSIONAL CIVIL AND ELECTRICAL ENGINEERING SERVICES IN THE BERGRIVIER MUNICIPAL AREA FOR A PERIOD OF THREE YEARS**. Only tenderers who satisfy the eligibility criteria stated in the Tender Conditions and Tender Data are eligible to submit tenders.

Tenders in sealed envelopes clearly marked "**TENDER 8/3/5-2020 MN9-2020: APPOINTMENT OF CONSULTING ENGINEERS**", must be deposited in the tender box at the Municipal Offices, 13 Church Street, Piketberg before **1200 on Tuesday, 10 March 2020**, when tenders will be opened in public.

Tenders will be evaluated in two stages - firstly eligibility and functionality will be assessed, where-after all responsive tenders will be evaluated in accordance with Council's Supply Chain Management Policy. The contract is classified as a large contract and the **80/20 point system** will be used for evaluation of the contract.

**A non-refundable tender fee of R500 (Five Hundred Rand)**, payable in favour of the Bergrivier Municipality, is required on collection of the documents. Tender documents can be obtained during office hours on weekdays at the Supply Chain Management Department, Municipal Offices, 13 Kerk Street, Piketberg, 7320. Tenders must be valid and binding for one hundred and twenty (**120**) days after closing date.

**A compulsory site meeting will take place on 19 February 2020 at 12H00 at the Library Hall, Kerk Street, Piketberg.**

Bidders must be registered as a prospective supplier on National Treasury's Central Supplier Database (CSD). The Tax Clearance Certificate/ Tax Compliance Status (TCS) Pin/ Centralised Suppliers Database (CSD) Registration Number must be submitted together with the bid. Failure to submit a Tax Clearance Certificate/TCS Pin/CSD registration number may result in the invalidation of the bid.

Only bids completed in **black** ink on the original Bid documentation will be accepted. Late, incomplete or Bids submitted by facsimile or email will not be accepted. Proof of submitting a Bid will not be accepted as proof of the Bid having been received. **The Municipality is not obliged to accept the lowest or any Bid submitted to it. The Municipality reserves the right to accept any Bid in full or in part.**
