### **TENDER NO. 8/3/6-2017(MN36/2017): THE CONSTRUCTION OF THE DRIVER'S LICENSE TEST YARD FOR PIKETBERG**

Bids are invited from registered and authorised suppliers for the construction of the Driver's Licence Test Yard for Piketberg.

Bids in a sealed envelope, clearly marked "**TENDER NO.8/3/6-2017(MN36/2017): CONSTRUCTION OF THE DRIVER'S LICENSE TEST YARD FOR PIKETBERG**" must be placed in the tender box in the Municipal Offices, 13 Church Street, Piketberg no later than **12:00 on Friday, 31 March 2017** when the bids will be opened in public.

Bids will be evaluated using the Council's Supply Chain Management Policy. It is therefore compulsory that the Preference Point Claim form for the Preferential Procurement Regulations is completed in full to make application for preference points. **The Bid price must be VAT inclusive.**

Bid documents and specifications are available at a cost of **R400 per set** and can be collected from Ms M van Zyl at the Bergrivier Municipal Offices. Only cash payments or cheques made out in favour of Bergrivier Municipality will be accepted. A **valid original tax clearance** certificate issued by the South African Revenue Service (SARS) must be included with bids.

A **compulsory clarification meeting** will be held on **Friday, 17 March at 09:00** at Bergrivier Municipality's Traffic Department Office / Testing Yard: 13 Vervoer Crescent, Industrial Area, Piketberg. Prospective tenderers who arrived later than **09:15** will not be allowed into the clarification meeting.

Tenderers must be registered with the **CIDB in a CE Class** of construction works and have a grading designation equal to or higher than that determined in accordance with the sum tendered or a value determined in accordance with Regulation 25(7A) of the Construction Industry Development Regulations, 2004. It is estimated that tenderers will need a grading designation of **3CE or higher.**

Late, incomplete or Bids submitted by facsimile will not be accepted. Proof of submitting a Bid will not be accepted as proof of the Bid having been received. The Municipality is not obliged to accept the lowest or any Bid submitted. The Municipality reserves the right to accept any Bid in full or in part.
