Tenders are hereby invited from service providers for the Provision of Traffic Law Enforcement equipment, back office System and related services to Bergrivier Municipality from 01 July 2018 until 30 June 2021 (3 years), as set out in the tender documents and specifications. The tender will remain valid for ninety (90) days after the closing date of the tender.

Bids will be evaluated using the Council's Supply Chain Management Policy. It is therefore compulsory that the Preference Point Claim form for the Preferential Procurement Regulations is completed in full to make application for preference points. **The Bid price must be VAT inclusive.**

Proof of submitting a Bid will not be accepted as proof of the Bid having been received. The Municipality is not obliged to accept the lowest or any Bid submitted to it. The Municipality reserves the right to accept any Bid in full or in part.
